FY 2021 Transportation Improvement Program Amendments

Program. The amendment to was to add a new project to the State Highway Project Section of the FY 2021 program year. The project was HIL-21-005, Illinois Route 50 (Harrison Ave) at Station Street and at River Street, in Kankakee, for traffic signal modernization. The project had a total cost of \$350,000 and was funded by National Highway Performance Program (NHPP) in the amount of \$280,000 and a local match of state funds in the amount of \$70,000.

Mr. Piggush motioned to recommend and forward the FY 2021 TIP Amendment for approval by the Policy Committee. Mr. Mulholland seconded the motion. Unanimous vote. Motion carried.
